

Data Protection Statement

1. General information

iwCLL e.V. (a registered association under German law) is an international, non-profit association, which is committed to creating progress regarding the management and outcome of patients with chronic lymphocytic leukemia world-wide.

This page provides information on how data is processed in connection with your use of this website, which is subject to the General Data Protection Regulation (GDPR) and Data Protection Act of Nordrhein-Westfalen (DSG NRW).

2. Responsibility

The iwCLL e.V. (a registered association under German law) is the controller in the sense of the GDPR, other data protection acts applicable in the member states of the European Union and other provisions of a data protection nature. You can contact the board of the registered association at:

3. Legal bases and purposes of data processing

Personal data is processed when iwCLL e.V. fulfils its responsibilities and duties. Sometimes this happens automatically via the internet browser and sometimes when the user enters data themselves. The section below explains the various ways personal data is electronically processed.

3.1 Website

When you visit the website of iwCLL e.V., user data is sent to the webserver via your internet browser. This information is saved temporarily in a log file. The following data is recorded while there is a connection between the internet browser and the webserver for communication and is saved until it is automatically erased after 100 calendar days:

- IP address of the requesting computer
- date and time of access
- name and URL of the requested file
- website from which our website is accessed
- web browser and the operating system used on the end device.

3.2 Forms

Personal data is collected on various parts of the website of iwCLL e.V. through online forms. The personal data that is sent to us is clear from the respective form. These forms are used on a voluntary basis. If you use our forms to contact us, we will receive your message as a email. The personal data contained therein may be forwarded to the respective responsible persons of iwCLL e.V., who will process your matter.

3.3 Emails

You can, of course, email us as well. Please note, however, that information that you send by unencrypted email to iwCLL e.V. is unsecured and could be read or modified by third parties during transmission. You should, therefore, not use this method to send us sensitive data. The first time you send us an unencrypted email, we will assume that you consent to unencrypted communication by email, unless you explicitly specify a different form of communication.

4. Links

The website of iwCLL e.V. maybe contains links to external websites. When the links were incorporated, the linked websites did not contain any sign of illegal content. iwCLL e.V. has no control over the current and future design, content or authorship of the linked pages. Therefore iwCLL e.V. is not responsible or liable for the content.

5. Duration of storage

iwCLL e.V. stores personal data for as long as required in consideration of the retention periods for fulfilment of the respective task in order to achieve the purpose of the processing and storage. Personal data sent to the webserver via your internet browser when you visit the website is stored for ten calendar days. In addition, in some circumstances personal data may be further processed. Data may also be stored if the storage is provided for by the European or national legislature in EU regulations, legislation or other provisions. As soon as the data no longer needs to be stored or a storage period prescribed by the above regulations expires, the personal data will be blocked or deleted.

6. Sharing your data with third parties

We will only share your personal data with third parties subject to your consent or if we are legally obliged to do so.

7. Photographic images

As part of the work of iwCLL e.V. photos are often taken and used at events. You may be identifiable in such photos. If you do not consent to this, you can object to the photo being taken and/or published. Please speak to the photographer immediately or use the above contact details to communicate your objection.

Please note that we have no control over photographs taken by press and media representatives. These are controllers themselves according to the GDPR.

8. Rights of data subjects

Based on Article 15 ff. GDPR, you have the following rights with regard to the processing of your personal data by iwCLL e.V.:



8.1 Right to information

You have the right to obtain confirmation from iwCLL e.V. as to whether personal data concerning you are being processed, and, where that is the case, you have a right of access to the personal data and the information listed in detail in Article 15 GDPR.

8.2 Right to rectification and if necessary completion

You have the right to obtain from iwCLL e.V. without undue delay the rectification of inaccurate personal data concerning you. Taking into account the purposes of the processing, you have the right to have incomplete personal data completed – including by means of providing a supplementary statement (Article 16 GDPR).

8.3 Right to erasure ('right to be forgotten')

You have the right to obtain from iwCLL e.V. the erasure of personal data concerning you without undue delay, and iwCLL e.V. must erase personal data immediately where one of the reasons listed in Article 17 GDPR applies.

8.4 Right to restriction of processing

You have the right to demand a restriction of processing by iwCLL e.V. if one of the conditions in Article 18 GDPR is met.

8.5 Right to notification

If you have asserted your right to rectification, erasure or restriction of processing, iwCLL e.V. is obliged to communicate any rectification or erasure of personal data or restriction of processing to each recipient to whom the personal data concerning you have been disclosed, unless this proves impossible or involves disproportionate effort. You are entitled to be notified of these recipients (Article 19 GDPR).

8.6 Right to data portability

You have the right to receive the personal data concerning you in a structured, commonly used and machine-readable format and to forward this data to another controller; see Article 20 GDPR.

8.7 Right to object

You have the right to object at any time, on grounds relating to your particular situation, to the processing of personal data concerning you. iwCLL e.V. shall then cease to process the personal data; see Article 21 GDPR. The recording of data to provide the website and the storage of data in logfiles is essential to the operation of the website. The user, therefore, has no option to object to this.

8.8 Right to lodge a complaint

Without prejudice to any other remedy, you have the right in accordance with Art. 77 Para. 1 GDPR to lodge a complaint with a supervisory authority if you consider that the processing of personal data relating to you infringes the GDPR. In Nordrhein-Westfalen, the competent supervisory authority is:

8.9 Withdrawal of consent

If you have consented to your personal data being processed by iwCLL e.V. by way of relevant declaration, you can withdraw this consent for the future at any time; see Art. 7 Para. 3 GDPR. This will not affect the lawfulness of the processing of data based on the consent up until the withdrawal. You can withdraw your consent from us at any time in any format.
